	2)	The NCC Directorate, Andhra Pradesh & Telangana shall be responsible to draw the merit list in respect of the NCC Cadets seeking admission under NCC Category for all the candidates.		
	3)	In case of a tie, TSPOLYCET merit will be the deciding factor for position in the merit list under NCC category.		
	4)	Only NCC Certificates issued by NCC authorities shall be valid.		
	5)	The above priorities will be given to the Certificates acquired if the candidates represent through NCC only and the same has to be endorsed on the Certificate.
